Director, Sol Education Hong Kong Limited

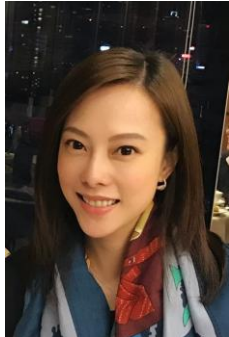

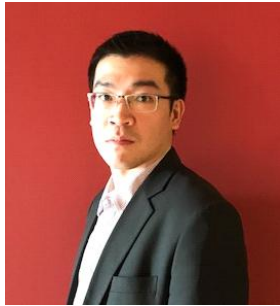

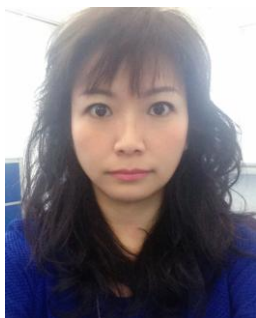
