Introduction

The Graduate Employment Survey is conducted annually by the Career Centre of the Office of Student Affairs. Its purpose is to find out the general employment situation of the full-time graduates for the year. The survey reveals the graduates' first career destination, remuneration information, job search process and career preparation and development.

Methodology

Graduates are invited to fill in an online questionnaire when they enroll for the Commencement Ceremony. Follow-up phone calls are made to non-respondents. Following the University Grant Committee's (UGC) guidelines, information on employment status of 2019 graduates was gathered up to 31 December 2019.

The bulk of the analysis is concentrated on the graduates engaged in full-time employment. The classification on job nature and employment field is derived from the classification system provided by UGC. Details of the classification on employment sector, employment field and job nature are shown in the Glossary.

Response

The survey targeted all 2019 full-time graduates of the University. As shown in Appendix 1, this year, a total of 2,783 graduates completed their undergraduate studies. In addition, there were 2,032 full-time taught postgraduates and 85 full-time research postgraduates. For the ease of report reading, courses/majors/options are grouped under their respective Faculties/Schools/Academy.

Out of the 2,783 undergraduates, 2,585 valid responses were received, representing a response rate of 92.89% (92.43% in 2018). Besides, a total of 1,883 valid questionnaires were collected from full-time postgraduates.



Executive Summary



SECTION A: Full-time Undergraduates

Overall Employment Status

At the close of the survey, 82.05% of the graduates were in employment. The percentages of graduates in full-time employment and self-employment were 70.75% (74.01% in 2018) and 4.84% (3.90% in 2018) respectively. The percentage of graduates pursuing further studies was 9.25% (12.20% in 2018). The unemployment rate was 2.40% (0.99% in 2018).

Employment Sector and Job Nature

Similar to last year, the percentage of graduates employed in the Community / Social Service Organizations was 11.30% (11.60% in 2018). The percentages of graduates employed in the Commercial / Industrial sector and the Government sector increased to 64.66% (62.71% in 2018) and 3.44% (2.77% in 2018) respectively. On the contrary, the percentage of graduates employed in the Education sector decreased to 20.60% (22.92% in 2018).

Administration / Management (17.74%) continued to rank the most frequent job nature. The other top five job natures were distributed among the categories of Marketing / Sales (9.23%), Accounting / Auditing / Taxation / Secretarial Work (7.45%), Teaching / Lecturing (Assistant) (6.56%), Teaching / Lecturing (Others) (6.23%) and Human Resources (4.95%).

Remuneration

The average monthly salary (including commission, allowances and any year-end bonuses) was \$17,190.77, an increase of 5.73% (\$16,259.66 in 2018). There was a rise in the salary among the Community / Social Services sector, the Education sector and the Commerce / Industry sector (increase of 12.80%, 7.62%, and 4.79% respectively). On the contrary, there was a 4.78% decrease in the salary of the Government sector.

Further Studies

239 graduates pursued further studies, which accounted for 9.25% of our 2019 graduates (12.20% in 2018). Among those graduates, 87.03% continued their study in postgraduate / master or above level of studies. Hong Kong Baptist University and The Chinese University of Hong Kong were the most popular local institutions, enrolling 30.36% and 23.81% of our graduates respectively.

SECTION B : Full-time Taught / Research Postgraduates

Overall Employment Status

93.97% of the taught postgraduates (93.14% in 2018), who were seeking local opportunities, were in employment with 92.43% working full-time or self-employed, 1.20% engaging in part-time employment, and 0.34% being temporarily employed.

Meanwhile, 95.46% of the research postgraduates (100.00% in 2018), who were seeking local opportunities, were in employment with 84.09% working full-time or self-employed, 6.82% engaging in part-time employment and 4.55% being temporarily employed.

The percentages of non-local taught postgraduates and research postgraduates emigrated or returning to home country increased by 0.37% and decreased by 18.54% respectively.

Employment Sector and Job Nature

The Commercial / Industrial sector has absorbed the largest proportion (66.01%) of the taught postgraduates (81.30% in 2018), followed by the Education sector, capturing 27.08% of them (17.28% in 2018).

Among the research postgraduates, 68.57% were employed in the Education sector (65.52% in 2018), followed by 20.00% of those employed in the Commercial / Industrial sector (31.03% in 2018).

Remuneration

The average monthly salary (including commission, allowances and any year-end bonuses) increased from \$18,485.28 in 2018 to \$19,486.70 in 2019 for taught postgraduates. Meanwhile, the average monthly salary of research postgraduates was \$29,128.54, an explicit increase from 2018 (\$24,280.00).

Further Studies

The percentage of taught postgraduates who chose to pursue further studies fell slightly from 3.27% in 2018 to 1.93% in 2019, while research postgraduates fell from 5.63% in 2018 to 4.41% in 2019.





Figure 2: Percentage of Full-time Employed Graduates by Employment Sector









Figure 5: Distribution of Full-time Employed Graduates with China Related Employment among Those Who Needed to Work Outside Hong Kong for the Years of 2015 to 2019


Figure 6: Number of Job Offers Received by Full-time Employed Graduates





Figure 10: Destination of Further Studies




Figure 11: Local Institutions for Further Studies





Figure 12: Reasons of Pursuing Further Studies





Distribution of Respondents by Employment Status – Taught Postgraduates and Research Postgraduates




Employment Status - Taught Postgraduates
