(a) Grant

- (i) If your result notification is issued on or before 7 November 2023, the second instalment of grant will be credited to your designated bank account on 24 November 2023.
- (ii) If your result notification is issued after 7 November 2023, the grant will be credited to your designated bank account in one instalment within 2 weeks from the date of issuance of the notification.

(b) Loan

- (i) If you submit the duly completed loan document to this office on or before 27 October 2023, the second instalment of loan will be credited to your designated bank account on 24 November 2023.
- (ii) If you submit the duly completed loan document to this office after 27 October 2023, the loan will be credited to your designated bank account in one instalment within 3 weeks from the deadline as specified in the notification. If you miss the deadline, the payment will be postponed depending on the date of submission of loan documents.

(甲) 若申請人在二〇二三年九月十五日或之前把填妥的貸款文件交回本辦事處：

本處將根據你接受的貸款額及所選的支付貸款方法，分兩期(如適用)發放有關貸款予你就讀的院校，用作支付你的學費，詳情如下一

- (i) 第一期的貸款已 / 將於繳付上學期學費的到期日或之後發放，過數日通常在申請結果通知書所述的截止遞交文件日期起計的八星期內；及/或
- (ii) 第二期的貸款會於繳付下學期學費的到期日(即二〇二三年十二月十三日)發放。

(乙) 若貸款申請於二〇二三年九月十五日仍在審核階段或申請人在二〇二三年九月十五日後才把填妥的貸款文件交回本處以接受獲批的貸款：

本處在完成審核後，會將結果盡快分批通知申請人。無論你選擇任何支付貸款方法，我們都會把你接受的全數貸款一次過發放給你就讀的院校。若你在二〇二三年十月二十日或之前把填妥的貸款文件交回本處，我們會安排在二〇二三年十二月十三日發放貸款；否則，有關貸款將會視乎遞交貸款文件日期順延發放。

Non-means-tested Loan Scheme for Full-time Tertiary Students (NLSFT) 2023/24
Disbursement Arrangement of NLS Loan to
Applicants Studying Full-time Courses of Hong Kong Baptist University

Taking into account all the relevant factors, including the payment due date of the second term tuition fee of the full-time Bachelor's Degree and/or Sub-degree courses (if applicable) set by your institution, we are pleased to inform you of the following payment arrangement –

(a) For those applicants who submit the duly completed loan documents to this office on or before 15 September 2023:

According to the amount of NLSFT loan you borrow and the loan option you choose, we will disburse the NLSFT loan in two instalments, if applicable, to your institution to settle the tuition fee(s) on your behalf –

- (i) The first instalment of the NLSFT loan has been/will be disbursed on or after the payment due date of the first term tuition fee. The date of disbursement is usually within 8 weeks after the deadline of submitting the loan documents as specified in the Notification of result; and/or
- (ii) The second instalment of the NLSFT loan will be disbursed on the payment due date of the second term tuition fee (i.e. 13 December 2023).

(b) For those applicants whose applications are being processed by this Office as at 15 September 2023 or those who submit the duly completed loan documents to this office after 15 September 2023:

Once the processing of applications completes, the applicants will be notified of their application results as soon as possible in batches. Irrespective of the loan option you choose, we will disburse the full amount of your accepted NLSFT loan to your institution in one instalment. If you submit the duly completed loan documents to this office on or before 20 October 2023, we will disburse the NLSFT loan on 13 December 2023. Otherwise, the disbursement of NLSFT loan will be postponed depending on the date of submission of loan documents.

Remittance advices detailing payment arrangement will be sent to applicants around four weeks before the NLSFT loan disbursement date.
