A. Important Notes:

- 1. Residents shall apply for approval before using any electrical appliances in their rooms which are not provided by NTTIH management. NTTIH management reserves the authority to reject the application, or to charge the resident for use of additional appliance.
- 2. The list of allowed/prohibited items in this guideline is not exclusive, should students have any queries to the application for using of additional electrical appliances in NTTIH, please complete the application form and send it to santtsr@hkbu.edu.hk for approval.
- 3. NTTIH management will review this guideline from time to time and reserves the right to update it as deemed appropriate.

B. Guidelines:

- 1. Electrical appliances of high wattage and/or in bulky size are **NOT** allowed to be used in NTTIH.
- 2. Residents are responsible to ensure that the additional electrical appliance complies with the safety requirements prescribed in the Electrical Products (Safety) Regulation of Hong Kong.
