# **General Information on Student Residence Application**

(For Full-time UGC-funded Research Postgraduates)

You should read carefully and thoroughly the information below before submitting the Student Residence application. You should contact the Student Accommodation Section if any enquiries or clarifications are needed. Failure to comply with the Student Residence application procedures and to provide correct and complete information may lead to disqualification of Student Residence application or delay in the process of the Student Residence application.

## **Special Attention for 2024/25 Student Residence Application**

You are requested to pay attention to and take into consideration the following notes and make sure that you understand and agree with them before you submit your student residence application. No refund or any form of compensation will be considered arising from such situations and arrangements below.

- 1. The construction of <u>Jockey Club Campus of Creativity (JC3)</u> is underway from 7 am to 7 pm from Mondays to Saturdays, except Sundays and public holidays. During the construction period, **nuisances such as noise, dust and smell will inevitably be expected**. Mitigation measures will be taken by the Estates Office to minimize the nuisances incurred by the construction of JC3 as far as practicable. Residents are advised to close windows of their rooms to alleviate nuisances as appropriate. Your continued understanding and patience will be greatly appreciated. **Please contact the Estates Office should you have further questions**.
- 2. Facial Recognition System for access control will be implemented in the Village CARE around the First Quarter of 2025. The current protocols would be strictly adhered to protect personal data and the privacy of staff, residents, visitors and outsourced workers of the Student Residence. Further details will be released in due course.
- 3. A late check-out penalty of \$600 will be charged per day after the stipulated latest check-out time until the check-out procedures are completed.
- 4. Students with special circumstances can apply for late check-out 2 weeks before the mass check-out. The late check-out application result will be released 3 days before the mass check-out date. An approved late check-out administrative fee of \$200\* per night shall apply to all approved cases. A student can request for late check-out for no more than 3 nights.
- 5. **Visitation in the Village CARE will be suspended** on the Mass Check-out Date and the following 5 days.

By completing and submitting the Student Residence application, you acknowledge that:

- 1. you have read, understood, and agreed the terms and conditions of the Student Residence application contained herein;
- agree to abide by the relevant rules of the Student Residence including the <u>Terms and Conditions</u>, <u>Hall Rules and Residents' Code</u> of the Village CARE, <u>and</u> any other rules that the University may prescribe and issue from time to time which it deems necessary for the management of the Student Residence.
- 3. the rules referred to in 2 above may include safety and health measures aimed at protecting

the University's community and all users of Student Residence services and their residents.


## **Eligibility for the Student Residence**

No guarantee of University accommodation will be provided starting from the second year of their studies.

### **Student Residence and Residential Education**





The Village CARE comprises 4 Residential Colleges with the vision to offer the best learning experience for students in a residential setting, delivering transdisciplinary academic excellence in a caring, creative, and global culture. The South & East Blocks have commenced operation and the North & West Blocks will be available for accommodation from Semester 2, 2024/25.

## **Requirements for Residents in Residential Colleges:**

- (1) Residents are required to attend at least one High Table Dinner each semester.
- (2) Each College will organize activities aligned with its theme, and residents are required to participate.

(3) Residents' involvement, performance and attendance in College activities will be taken into consideration and affect their applications as returning students to the Student Residence in the future.

#### Residential Period for Semester 2, 2024/25

Successful Student Residence applicants for Semester 2, 2024/25 are to be offered Student Residence places from 9 Jan 2025 to 22 Jul 2025, both nights inclusive. Students are to check out by 12 pm on 23 Jul 2025 subject to further arrangements by the management office.

#### **Preference on Room Type and Roommate**

- 1) You need to rank your room type preferences carefully in the application.
- 2) You may indicate **up to 1** preferred roommate\* in the application.
- 3) If you and your preferred roommate(s) are successful in the Student Residence application, you will be grouped together and share the same random number in the room type assignment

- process. All applicants will be assigned to their respective preferred room type based on the order of this random number. Please note that random numbers are given regardless of your student residence marks.
- 4) Choices of Student Residence, floors, room type and roommates will be met only as far as practicable.
- \*Note: Your roommate pairing request will NOT be successful (you will be assigned a roommate randomly) if:
- a) your preferred roommate(s) does not complete the application;
- b) your preferred roommate(s) does not choose you as preferred roommate;
- c) your preferred roommate(s) chooses another student(s) to be his/her preferred roommate(s); OR
- d) another student chooses you or your preferred roommate(s) to be his/her preferred roommate(s)

#### **Possibility of Room Relocation**

For the sake of efficient utilization of resources and to facilitate timely repairs to the rooms, the Management of Student Residence reserves the right to relocate residents to other rooms within the Student Residence by normally serving at least five days' notice in advance.

#### Student Accommodation Fees and Payment (\*1st installment Payment Period): 5-11 Dec

Student Accommodation Fees for students are to be paid in two installments and are NOT transferrable or refundable. Student Accommodation Fees for 2024/25 2nd Semester are listed below for reference:

<sup>\*</sup> In addition to lodging fees, all residents need to pay Caution Money (\$1,000) and other miscellaneous fees as appropriate.

Details of the Lodging fees are as follows:

- Lodging fees paid are not refundable (except Caution Money) nor transferrable even if the applicant withdraws study from HKBU.
- Applicants should settle the Lodging Fees on or before 11 Dec 2024.
- The \$1,000 Caution Money is refundable to residents only after completion of the committed lodging period, less any restitution charges for damage or loss of properties and keys and late check-out. For residents checking out during semester break or before the last day of class of semesters or during semester break, a \$100 administrative fee will be deducted from the Caution Money before refund.

## Octopus Card for Air Conditioning and Laundry Service

Residents can charge up the air conditioner, other utility payments in their room and laundry machines on 9/F (for East Block & South Block) or 14/F (for North Block & West Block) by Octopus Card.

Applicants for Village CARE should take note that, in addition to the in-room air-conditioning, other electricity consumption within their bedrooms and units/apartments will be charged based on a user pay principle.

## **Check-in Procedures**

The earliest check-in date is 9 Jan 2025 (10am – 6pm). No early check-in will be considered since rooms will NOT be available earlier. Please click <u>HERE</u> for check-in procedures.

## **Late Check-out Penalty**

A late check-out penalty of \$600 will be charged per day after 12 noon of each late check-out day until the check-out procedures are completed.

Students with special circumstances can apply for late check-out 2 weeks before the mass checkout. The late check-out application result will be released 3 days before the mass check-out date. An approved late check-out administrative fee of \$200 per night shall apply to all approved cases. A student can request for late check-out for no more than 3 nights.

#### Works within or in proximity to the Student Residence

You are informed and shall acknowledge that the University is almost constantly undertaking works to maintain, enhance and develop its campus and all its facilities, and these works may include but are not limited to construction, renovation, remedial works, repair and maintenance, improvement works or other similar works in whatsoever nature (the Works). These Works may be carried out within or in the proximity of the Village CARE. While the Estates Office will, as far as practicable, take reasonable measures to minimize the inconvenience and disturbance caused by the Works, you should acknowledge that total removal of such inconvenience and disturbance may not be possible, and they shall agree to waive irrevocably any claim for refund of hall fees, or any right to seek compensation for any loss or damage directly or indirectly arisen out of any inconvenience caused to or suffered or sustained by them as a result of the Works.

Your attention is hereby drawn to the following Work(s) during the Residential Year of 2024/25. You shall take this into consideration before submitting the application, accepting the student residence offer and paying the student accommodation fees.

- Façade Enhancement Project at Undergraduate Halls
- Construction of the Jockey Club Campus of Creativity
- Government Project at Renfrew Road Construction of Special Schools

## **Arrangement on Special Circumstances**

If there are uncontrollable circumstances and the University makes related announcements, like asking students not to come back, delaying the check-in date or evacuation of the Hostels, refund of lodging fees, if justifiable, can be made at most on a pro rata basis. However, the above suggestion of a possibility of refund by no means constitute a guarantee. You should consider this when you decide on lodging fees payment.

You may also note that under very special circumstances, the Management of Student Residence will need to relocate residents to other rooms / floors / residential facilities for various purposes, such as to accommodate urgent repairs and renovations, consolidation in low seasons, quarantine for health protection, etc. You are reminded to consider such possibilities before accepting our offer of residence place.
