**(a) Grant**

- (i) If your result notification is issued on or before 10 November 2021, the second instalment of grant will be credited to your designated bank account on 26 November 2021.
- (ii) If your result notification is issued after 10 November 2021, the grant will be credited to your designated bank account in one instalment within 2 weeks from the date of issuance of the notification.

**(b) Loan**

- (i) If you submit the duly completed loan document to this office on or before 4 November 2021, the second instalment of loan will be credited to your designated bank account on 26 November 2021.
- (ii) If you submit the duly completed loan document to this office after 4 November 2021, the loan will be credited to your designated bank account in one instalment within 3 weeks from the deadline as specified in the notification. If you miss the deadline, the payment will be postponed depending on the date of submission of loan documents.

### **Non-means-tested Loan Scheme for Full-time Tertiary Students (NLSFT) 2021/22** **Disbursement Arrangement of NLS Loan to** **Applicants Studying Full-time Courses of Hong Kong Baptist University**

Taking into account all the relevant factors, including the payment due date of the second term tuition fee of the full-time Bachelor's Degree and/or Sub-degree courses (if applicable) set by your institution, we are pleased to inform you of the following payment arrangement –

**(a) For those applicants who submit the duly completed loan documents to this office on or before 22 October 2021:**

According to the amount of NLSFT loan you borrow and the loan option you choose, we will disburse the NLSFT loan in two instalments, if applicable, to your institution to settle the tuition fee(s) on your behalf –

- (i) The first instalment of the NLSFT loan has been/will be disbursed on or after the payment due date of the first term tuition fee. The date of disbursement is usually within 8 weeks after the deadline of submitting the loan documents as specified in the Notification of result; and/or
- (ii) The second instalment of the NLSFT loan will be disbursed on the payment due date of the second term tuition fee (i.e. 15 December 2021).

**(b) For those applicants whose applications are being processed by this Office as at 22 October 2021 or those who submit the duly completed loan documents to this office after 22 October 2021:**

Once the processing of applications completes, the applicants will be notified of their application results as soon as possible in batches. Irrespective of the loan option you choose, we will disburse the full amount of your accepted NLSFT loan to your institution in one instalment. If you submit the duly completed loan documents to this office on or before 9 November 2021, we will disburse the NLSFT loan on 15 December 2021. Otherwise, the disbursement of NLSFT loan will be postponed depending on the date of submission of loan documents.

Remittance advices detailing payment arrangement will be sent to applicants around four weeks before the NLSFT loan disbursement date.

本處在完成審核後，會將結果盡快分批通知申請人。無論你選擇任何支付貸款方法，我們都會把你接受的全數貸款一次過發放給你讀的院校。若你在二〇二一年十一月九日或之前把填妥的貸款文件交回本處，我們會安排在二〇二一年十二月十五日發放貸款；否則，有關貸款將會視乎遞交貸款文件日期順延發放。
